## ADMISSION POLICY

Mount Calvary Junior Academy is a Seventh-day Adventist operated church school. We admit students of any race, color, and ethnicity, country of origin, religion, or gender. They are entitled to all the rights, privileges, programs, and activities generally accorded or made available to students at this school. We do not discriminate on the basis of race, color, ethnicity, religion, country of origin, or gender in the administration of educational policies, application for admission, scholarship, or extracurricular programs.

# REGISTRATION AND ADMISSION PROCEDURES

The parents or guardians of all students applying to the academy MUST be present at the school to complete their registration on the scheduled dates. A conference with the principal will be scheduled, and placement tests in math and reading will be administered to the student seeking admission. The admissions committee will then review all applications and other documents to determine admission. We require the following on the day of registration:

- 1. Completion of all applicable forms in the registration package
- 2. Current copy of physical/immunization information. These forms must be signed by a qualified physician
- 3. Two good character references
- 4. Willingness of students and parents/guardians to live by the written and verbal policies and guidelines of the school
- 5. Meeting financial obligations, including afterschool care, and supporting the school's programs
- 6. Transcripts and records of previous schools attended
- 7. Birth certificate (Kindergarten and first grade students only).
- 8. Registration fees and first tuition installment.
- 9. A Social Security Number.

Signing the registration form is a contract indicating that the parents or guardians and students pledge to respect the principles of Mount Seventh-day Adventist Academy and support the requirements and regulation.

## SCHOOL OPENING COVID-19 GUIDING STATEMENT

Mt. Calvary Jr. Academy will implement practical best practices for opening school in the Covid-19 environment as outlined in this document. Under general principles of liability law, the school is freed from being responsible if we are deemed to be taking reasonable steps to protect students. As the nation continues to struggle to find ways to stem the spread of Covid-19, there is no clear definition of what steps would protect schools from being held legally liable.

Mt. Calvary Jr. Academy will modify their physical spaces based on guidance from the Conference, North America Division, national, state, and local health officials.

These guidelines will be modified and updated as new information becomes available from the CDC and the Southeastern Conference.

### PERSONAL PROTECTIVE EQUIPMENT (PPE)

- All employees and students will provide their own face mask..
- Wearing a mask is required at all times except
  - -When eating
  - -When socially distant outside

#### **WELLNESS & HYGIENE**

- Hands-free sanitizing stations will be provided throughout the campus.
- Frequent handwashing will occur throughout the school day
- When practical, windows and doors will be left open to increase air flow.
- Water fountains will be disabled. All students must bring their own water.

#### PUBLIC SIGNAGE & REINFORCED EXPECTATIONS

 All signage throughout the school facility regarding healthy hygiene, prevention and expected behaviors must be adhered to by everyone entering the campus.

#### ENHANCED FACILITY CLEANING

- Safe and effective cleaning agents will be used by all employees on high touch surfaces throughout the school day.
- Periodic HVAC air purification
- Regular fogging will be done

### **HEALTH SERVICES**

- All students and employees who are sick must stay home.
- All students and employees who become sick while at school must go home immediately.
- All students and employees who test positive for Covid-19 must quarantine for 5 days.

#### FOOD SERVICE - BREAKFAST/LUNCH

• Lunch time schedule will be staggered to accommodate social distancing in the cafeteria or designated areas.

## GRADE PLACEMENT

### **KINDERGARTEN**

Students desiring to enter Kindergarten must be five (5) years old by September 1 in the year seeking admission. Any exceptions must be cleared through the principal and the superintendent of education.

## **GRADE 1**

Students desiring to enter Grade 1 must be six (6) years old by September 1 in the year seeking admission. Any exceptions must be cleared through the principal and the superintendent of education.

## **GRADES 2-8**

We admit students to grades 2-8 providing they meet all registration requirements.

## ACADEMIC PROGRAM

Mount Calvary Seventh-day Adventist Academy provides Christ-centered quality education for the children and youth as it prepares them for life here and for the "higher joy of wider services in the world to come." *Education* by, E. G. White, p. 13.

### **CURRICULUM**

The school follows the curriculum guide outlined by the Southern Union Conference and General Conference of Seventh-day Adventist, in conjunction with the Educational Department of the State of Florida.

As a minimum, we offer the following core subjects:

Language Arts Social Studies STEM Education

Bible Science

Technology Engineering Mathematics

The school also offers the following auxiliary subjects:

Art Physical Education

Music/Violin Outdoor Education (Grade 6)

In addition to academics, the academy also offers the following diverse clubs and activities, whose availability will be determined by the number of interested students and the availability of personnel:

Spelling Bee 8<sup>th</sup> Grade Class Trip Field Trips Community Service Weekly Chapel Christmas Program

Track and Field Events Book Fair School Choir Science Fair

Robotics Club

The school also provides several programs, some that are federally funded and are offered at no cost to the parents or guardians. They include:

> Remedial Reading Remedial mathematics Hot Meals (Breakfast and Lunch, which are free to qualifying students)

The school receives federal funds through Title 1 of the Improving America's School Act. The purpose of these funds is to enable the academy to offer additional instructional assistance to students who need extra help.

### **RELIGIOUS PROGRAM**

The religious program of the school will serve to set the tone for the entire school day. Bible classes and activities will emphasize character building and will be based on examples found in the Bible. All students are required to participate in devotions, religious classes and week of prayer, and encouraged to participate in the other activities listed in Number 4 below.

The religious program will include, but will not be limited to the following:

- 1. **Devotional Periods** will begin and end each day.
- 2. **Bible** is a required academic class for all students. The Bible will be our main book of study.
- 3. **Week of Prayer** is a week of Spiritual Emphasis held at least once during the school year. We encourage parents and guardians to attend.
- 4. **Attendance and Participation** in different school functions held at different churches is required. These functions will include Christmas programs, Education Day Programs, Education Spotlights, Graduation services and Education Rally Day Programs.

### GRADES AND GRADING

We will issue students' report cards to parents and guardians according to the schedule on the school calendar. Parents or guardians must attend the scheduled parent/guardian and teacher/student conferences at the end of the first (1st) and third (3rd) quarters.

Parents or guardians will receive interim reports according to the schedule. It is the responsibility of the parent or guardian to seek a conference with the teacher in cases where the student's class work has been determined to be unsatisfactory.

Parents or guardians will be called in for a formal conference with the teacher when the quality of the student's work is deteriorating or is below an acceptable level. Report cards will be released at the end of each nine (9) week grading period, providing that the student's account is up to date.

All grades are recorded by the school on the student's permanent record. No report will be issued by the school if a student has lost a textbook or damaged school property until full restitution is made.

### **INCOMPLETE**

At the teacher's discretion, and based on justifiable reasons, students will receive a grade of "I" if they must make up the work because of legitimate excused absences. Students will have two (2) weeks to complete the work.

If they do not make up their assignments they will receive an unsatisfactory grade. Quarterly and "Incomplete" assessments must be removed within two (2) weeks after the close of the grading period.

## **ACADEMIC PROBATION**

A student who is failing in two (2) or more subjects may be placed on academic probation. A student on academic probation may be asked to withdraw from school if the grades do not improve to the passing level within a reasonable amount of time.

### GRADE POINT AVERAGE

To determine the grade point average (GPA), we will use the fourpoint system as follows:

### HONOR ROLL

To encourage all students to do their best academically and reward them for their achievements, we will list on the school's honor roll all students for that quarter who has received a minimum grade point average of 3.50. We will determine a yearly honor roll by calculating all grades for the year.

For the graduating class, we will calculate grades for the last three (3) years of school (grades 6-8) to determine whether or not a student graduates with honors.

## **TESTING**

The school administers achievement tests each year as part of the testing program of the Southeastern Conference of Seventh-day Adventist. We will discuss results of these tests with parents or guardians during parent /guardian and teacher/student conference. We will also place a copy of the results in the student's permanent record and send one copy home.

## **EXCEPTIONAL ABILITY**

As a rule, students with exceptional ability will not skip grades or take two (2) grades in one (1) year. Such students will receive enrichment through wider and more challenging studies and experiences. We will refer extreme cases to the superintendent for evaluation and upgrading.

### PHYSICAL EDUCATION

All students must participate in physical education classes. We will make exceptions with appropriate medical reports or reasonable parental requests.

## REQUIREMENTS FOR ACADEMIC PROMOTION

Students must maintain a minimum average of "C" in all subjects (grades 1-8) or its equivalent (kindergarten) for promotion to the next grade. Please note that a "D" is not a passing grade.

We will make exceptions to this rule only when, after counsel with parents/guardians, teacher, principal, and the superintendent, we decide that repeating a grade would be of absolutely no benefit to the student

## **GRADUATION REOUIREMENTS**

Eighth (8th) grade students who successfully complete all requirements for graduation will become members of the graduating class and receive a diploma after graduation.

Students must earn a minimum average final grade of "C" in all subjects. In addition to the academic requirements, students must

exhibit good moral character and must have satisfactory financial clearance from the school prior to graduation.

## **SCHOOL HOURS**

The school day is from 8:15 a.m. to 3:15 p.m. Mondays - Thursdays, and from 8:15 a.m. to 2:15 p.m. on Fridays.

Students may begin arriving to school at 7:00 a.m. Students arriving before 8:15 a.m. must report to the gym until school activities begin. Any student arriving after 8:15 a.m. is late. Students should be picked up from school no later than thirty (30) minutes after dismissal.

### AFTER-SCHOOL CARE

The school provides after-school-care for any student whose parents or guardians are unable to make adequate travel arrangements for. This service is from 3:46 p.m. to 5:30 p.m. Monday through Thursday, and 2:46 p.m. to 5:30 p.m. on Fridays.

Due to fact that the sun sets early in the winter months, after-school care will close at 4:30 on Fridays during that period. Signs will be posted with dates and times.

Any child remaining at school after 3:45 p.m. (2:45 p.m. Fridays) is automatically enrolled in the after-school care program. The fee for this is service \$10.00 per day, not to exceed \$80.00 per month. August and December will be \$40.00.

## **ATTENDANCE**

To fully benefit from the instructional curriculum, students are expected to attend school regularly, be on time for classes, and satisfy all course requirements. It is recommended that medical appointments, whenever possible, be scheduled after school hours. It is the responsibility of the parent/guardian to notify the school as soon as possible if a student will be tardy or absent.

## Acceptable excuses for nonattendance include:

- 1. Verified proof of the student's illness.
- 2. Verified proof of medical and dental appointments.
- 3. Verified proof of the need to be quarantined.
- 4. Verified proof of bereavement.
- 5. Verified proof of the need of the student's mandatory attendance at court proceedings.

# Unacceptable excuses for nonattendance include, but are not limited to the following:

- 1. Absence from school to take music, art, or other lessons.
- 2. Absence from school to run errands.
- 3. Absence from school:
  - a. to deliver papers
  - b. to help care for children
  - c. to help at home in cases of illness of other family members
  - d. because of lack of proper clothing
  - e. for recreation

# REPEATED ABSENCES, TARDINESS AND EARLY DISMISSALS

We may refer cases of students with excessive tardiness, early dismissals, or who accumulate four (4) or more unexcused absences to the school board for further action. We will also report these cases to the Department of Social Services, as required by state law. Excess of three (3) unexcused tardiness or absences may require parents or guardians to attend a conference with the teacher and or principal.

Students who are absent due to illness for three (3) or more consecutive days must present a doctor's excuse upon returning to school. All students who are tardy or absent must present a written excuse signed by the parents/guardians.

### TARDINESS AND ABSENCE PENALTY

A student who is absent more than twenty (20) percent of the school days (including excused tardiness and absences) in any given quarter and for whatever reason may forfeit his or her grades for that quarter, unless it is evident to the teacher that his or her work has been satisfactorily made up. Such a student may be placed on academic probation.

### DEPARTURE FROM SCHOOL

Students will leave school only with those individuals whose names are on the pick-up form. The school may require persons listed on the pickup form to present picture identification when picking up students.

During school hours, the school shall permit a student to leave the school only in the custody of the following individuals:

- 1. Parents/guardians who have legal custody of the student
- 2. Persons on the pick-up list (photo identification may be required)
- 3. An authorized worker from the Department of Children and Families
- 4. Law enforcement officers

Parents shall keep the office updated on any changes on the student pick-up list and transportation arrangements.

A student desiring to leave the campus on his/her own must present a written and signed request from the parent/guardian.

In the case of separated parents, the school will defer to the wishes of the individual with legal responsibility over the child as stated by the court. In such cases, parents/guardians with sole custody of a student must submit supporting documents from the court to the school.

To obtain an early dismissal, a student must provide a written request, signed by the parent or guardian. The request must state the reason for requesting the early dismissal. This will become part of the student's file.

### FINANCIAL INFORMATION

### **TUITION PLAN**

For your convenience, the first tuition installment is due at registration/enrollment. Please refer to your registration package for fees.

### **DISCOUNTS**

In a <u>family with two or more children attending the school</u>, the first child will pay the full tuition, the second child will receive a ten (10%) percent discount, and all other children will get a fifteen (15%) percent discount off of the tuition.

Parents/guardians who pay their children's tuition in full at registration/enrollment will receive a ten (10%) percent discount.

Parents/guardians, who pay fifty (50%) percent of the total tuition at registration will receive a five (5%) percent discount. A discount of five (5%) percent will also be given to parents/ guardians who pay the remaining fifty (50%) percent of their child's tuition by January 10.

Please note that the first payment is due upon enrollment.

## **DISHONORED PAYMENTS**

We will assess a returned check fee of twenty dollars (\$20.00) to your account for all unpaid checks the bank returns.

### **DELINQUENT ACCOUNTS**

Payment is due on the first of each month. An account will be considered to be overdue if payment is not received by the tenth school day of each month and a \$25.00 late fee will be added to the account.

The school reserves the right to suspend students from classes until their parents or guardians make satisfactory arrangements for payment of any outstanding bill.

Mount Calvary Junior Academy will forward all accounts that are not settled in a timely manner to a collection agency.

Parents and guardians are strongly urged to meet their financial obligation to Mount Calvary Junior Academy on time. If any parent or guardian is facing legitimate financial hardship, they must contact the principal immediately to make other payment arrangements.

Parents or guardians must make satisfactory arrangements for payment before students may return to class, write examinations, or receive grades or transcripts at the end of the quarter or school year.

The school will not accept students for registration if they have an outstanding balance at the school unless the parents or guardians make arrangements in writing, and submit it to the principal for the school board's approval.

Eighth grade and kindergarten students may not participate in graduation exercises or receive a diploma if their accounts are not settled prior to graduation. Students will not receive final grades or have transfers released until satisfactory settlement of their accounts is evident. Students and parents/guardians are responsible for:

- 1. Willful or intentional damage to personal or school property.
- 2. Loss or damage of textbooks and library books.

## **REGISTRATION FEE**

The Academy charges each applicant an annual registration fee at rates set by the school board. These fees help to cover the cost of student insurance, standardized tests, library fees and classroom supplies which are essential to our instructional program and general office overhead.

### **BOOK FEE**

Each student will be accessed a \$400.00 book fee to help cover the cost of text books.

## **GRADUATION FEE**

A graduation fee set by the school will be charged to each member of the graduating classes, (grades K & 8). This fee will cover the cost of cap and gown, diploma, class decorations, etc.

### **DRESS CODE**

The academy has a prescribed uniform to encourage uniformity and uphold the basic principles of modesty for all its students. Students in grades K-8 must wear the full uniform determined by the school.

The school's uniform is to be worn at all times, except for special occasions as determined by the school administration. Students must be well-groomed at all times. Whenever they appear in public they must be neat, clean, modest, and representative of a true Christian. We expect parents/guardians to cooperate with the school in these matters. Should a genuine emergency arise and a student must attend school out of full uniform, the parent/guardian must send a written and signed note, explaining the circumstances to the teacher and principal.

### REQUIREMENTS FOR BOYS

Boys must wear white short or long-sleeved button down shirts, (**polo type shirts are not allowed**) navy blue pants, navy blue or the school- approved plaid tie, solid black shoes, a black belt and navy blue or black socks.

Boys must have their shirts neatly tucked into their pants at all times. Tennis shoes are not permissible except during physical education class and recess.

No hats or sunglasses are allowed in the school building. Unless authorized by the teacher.

### REQUIREMENTS FOR GIRLS

Girls in grades K-4 will wear the approved plaid jumper. Girls in grades 5 –8 will wear the approved plaid skirts. With the jumper or skirt, the girls must wear white long or short sleeve blouses with Peter Pan collar, (**polo type blouses are not allowed**) crisscross

navy blue ties, navy blue or white socks or stockings, and solid black or navy dress shoes. THE GIRLS' SKIRTS AND JUMPERS MUST BE AT MODEST LENGTHS.

Tennis shoes are not permissible except during physical education class and recess. Girls may wear uniform colored hair bows, and hairstyles should be modest with no unnatural colors.

## **BOYS AND GIRLS**

Other stores may carry school uniform lines that meet the approval of Mount Calvary Junior Academy. If you make uniform purchases elsewhere, we strongly recommend that you save your receipts if you are not positive your purchase is a perfect match to the approved uniform.

Please purchase your uniforms early to be sure your child is in full uniform on the first day of school.

During winter months students may wear school approved sweaters to class. Students may not wear coats or non-uniform sweaters in class. Sweat shirts are not allowed in class.

If any child comes to school partially or completely out of uniform after the deadline, he/she will not be able to go to class. We will call the student's parents/guardians, ask them to pick the child up and change into uniform, or the parents or guardian may bring the uniform to school for the child.

Boys' pants, shirts, blue ties, girls' blouses and ties may also be found at the following stores: Wal-Mart, Burlington Coat Factory, Target, JC Penny's, and similar stores.

## **TAG DAY**

Tag days are the last day of each quarter. On these days, students may wear their regular clothes to school (uniforms not required).

Girls may wear modest dresses, capris, skirts, or pants. Spaghetti straps, short skirts, tank tops, tight, sleeveless or see through clothing are not allowed. The hem of the skirts and dresses should be no higher than two inches above the knees.

Boys may wear long pants or long shorts. Although students may wear regular clothes, they must be modest, neat and tidy.

On Fridays, students may wear a school t-shirt of their choice with denim blue or black jeans. If student is not in jeans and a school t-shirt or a uniform shirt, they must be in full uniform.

## **DRESS AND JEWELRY**

We encourage students to dress modestly without gaudy appearance. Students are not to wear or bring to school at any time, colored cosmetics, nail polish, items of jewelry including rings, bracelets, earring, necklaces, ornaments, and other types of jewelry The teacher or principal will confiscate these items until the end of the school year.

Any student wearing colored cosmetics, nail polish, etc., must clean it off immediately. If the student cannot remove it or if the student refuses to comply, suspension from class will immediately follow

### HOME AND SCHOOL ASSOCIATION

Parents, guardians, teachers, students, school board members, and community leaders comprise our Home and School Association. One of the main functions of the Association is to promote education programs for parents and guardians.

Since the success of a child's education can only be accomplished when parents and guardians work closely and effectively with the school, the commitment and participation of parents and guardians is critical.

To ensure the children's success, the association seeks the maintenance of a viable and effective learning environment for students in the home as well as the school.

It is vital, therefore, that all parents and guardians support the association in order to ensure the school's continued successful operation.

The other important function of the Home and School Association is to raise funds for the school. These funds go toward the purchase of classroom equipment and the improvement of the school's physical appearance. Parents and guardians are also urged to support the school's fundraising efforts and to volunteer, at least two (2) hours of their time each month toward school improvements.

## REGULATIONS

We operate the Mount Calvary Junior Academy with the highest Christian standards and ideals. Although we apply no religious test to those who apply for admission, the academy has for its definite purpose the development of spiritual ideals. Therefore, we do not permit a practice or influence that would inhibit the attainment of this objective in the character training of our students. We will make every effort to stimulate students to worthy scholastic endeavors and consistent Christian living. However, the board will not assume responsibility for students who are not in harmony with its announced purposes, or whose behavior is inconsistent with the school's requirements.

All students must obey all school rules and regulations. Students who violate the rules and regulations, even on the first offense, may be suspended or dismissed from school.

### **CAUSE FOR SUSPENSION**

- 1. Conspiracy or participating in hazing, initiations, or committing an act that injures, degrades, or disgraces a fellow student or teacher.
- 2. Failure to wear uniform without acceptable written excuse from parents/guardians.
- 3. Leaving the school without permission.
- 4. Instigating or participating in fights and other forms of boisterousness.
- 5. Tampering with or damaging school property.
- Dishonesty, including theft, willful deception regarding violation of school regulation, cheating during examinations, class work or any phase of school business.
- 7. Bringing electronic devices to school without teacher's permission.
- 8. Insubordination or defiance toward any teacher or staff member.
- 9. Wearing colored lipstick, eye-shadow, colored or frosty nail polish, or any gaudy, artificial cosmetics. Bringing or wearing jewelry such as earrings, rings, necklaces, bracelets and the like to school.

- 10. Using profane, indecent language, including lewd or suggestive conduct. Possessing or displaying obscene literature or pictures.
- 11. Gambling in any form, or possessing playing cards or other gambling devices.
- 12. Vandalism or willful destruction of any school or personal property.
- 13. Refusing to obey any school rule.
- 14. Bullying, including cyber bullying of another student.
- 15. Visiting inappropriate web sites or displaying inappropriate material from a web site.
- 16. Bringing a toy gun to school.

## **DISMISSAL FROM SCHOOL COULD RESULT FROM:**

- 1. Acquiring a third (3rd) suspension in one (1) school year.
- 2. Using, handling, possessing, selling or dispensing illegal drugs, narcotics, or tobacco in any form.
- 3. Drinking, handling, or possessing alcoholic beverages, or furnishing them to others.
- 4. Hitting, causing harm to, or threatening school personnel.
- 5. Bringing, using or possessing knives, razors, real firearms to school; using any object as a deadly weapon.
- 6. Disseminating immoral or atheistic ideas; undermining the religious ideals of the school; continuous fault finding.
- 7. Threatening to or participating in the destruction of the school by the use of fire, bombs, or any other means.
- 8. Blatant disrespect for authority.
- 9. Possessing or displaying inappropriate materials from books, magazines, the internet, or any other source.
- 10. Engaging in any form of sexual activity.

- 11. Threatening to or participating in acts of sexual harassment.
- 12. Loud, disrespectful or aggressive behavior of parents or other family members on school campus.

### **Definition:**

#### **Sexual Harassment:**

any behavior, verbal, or written, any gesture, physical touch or gesture, any teasing, jesting, criticizing or belittling, no matter what the intention, that is expressed against the wishes of the recipient. This offense can involve the following:

- touching, grabbing
- sexual remarks, terms
- pornographic pictures, stories
- dirty, suggestive jokes
- offensive display of sexual objects
- staring, stalking
- unwanted flirting
- comments about the body
- sexual suggestions, requests
- obscene gestures, symbols
- embarrassing practical jokes or pranks that are sexual in intent or design

A student whose progress or conduct is unsatisfactory, whose spirit and attitude are out of harmony with the standards and principles of the school, or whose influence is detrimental to the well-being of other students or the effective operation of the school's program may be dismissed at any time although there may have been no specific violation of any regulations.

In general, the principal will approve suspensions. Recommendations for dismissal will be referred to the school board.

## RESPONSIBILITIES OF STUDENTS TO THE SCHOOL

Every student enrolled in Mount Calvary Junior Academy must:

- 1. Respect the Bible as the inspired Word of God.
- 2. Practice principles of Christian morals, ethics, fair play, and be courteous.
- 3. Abstain from all forms of rough and uncouth behavior.
- 4. Keep language above reproach, refraining from smutty conversation and the use of profanity.
- 5. Uphold the rules and regulations of the school.
- 6. Always obey and respect the school staff, parents/guardians, and patrons. Maintain a constructive and cooperative attitude.
- 7. Dress in the full school uniform.
- 8. Attend school regularly and punctually.
- 9. Go directly to and from school in an orderly manner.
- 10. Leave the school premises during the school day only with permission of the principal and the request or approval of parents /guardians.
- 11. Pay for all willful damage and mutilation of school and personal property.
- 12. Refrain from the use of artificial cosmetics and wearing of jewelry.
- 13. Refrain from the use, handling, or possession of liquor, intoxicating beverages, tobacco, pipes, cigarettes, and narcotics in any form.
- 14. Actively participate in the learning process of the school.
- 15. Have the teacher's permission to bring electronic devices to school.

- 16. Present written excuse after being absent three consecutive days.
- 17. Refrain from cheating. If caught, students <u>will</u> automatically receive an  $\underline{\mathbf{F}}$ , and may be suspended.
- 18. Dress in a modest, healthful, and becoming manner.
- 19. Refrain from chewing gum at school.

Mount Calvary Junior Academy can deny access to its campus to any parent/ guardian whose conduct the school deems to be out of harmony with its stated guiding philosophy, rules, and regulations.

The academy's administration will determine the length of such a suspension. Additionally, the school also reserves the right to withhold services to the child of the parent/guardian in question.

### **RESPONSIBILITIES OF PARENTS AND GUARDIANS**

Parents and guardians shall make the attendance of their children effective by cheerfully attending to the following duties:

- 1. See to it that the students attend school on time every day.
- 2. Encourage students to remain on the school grounds during the entire school day.
- 3. Provide students with the necessary personal school supplies.
- 4. Encourage students to take care of books and supplies.
- 5. Encourage students to observe health principles.
- 6. Speak with the teacher after school hours, not during class time.
- 7. Consistently encourage students to obey and uphold the rules and regulations of the school.

- 8. Send a written excuse with a student who is tardy or returning to school after being absent.
- 9. Support the school's standards, regulations, and activities.
- 10. Pay all school bills and fees on time.
- 11. Attend Home and School Association meetings regularly.
- 12. Sign and return all communications the school requests.
- 14. Demand and expect the very best of your child/children.
- 15. Refraining from making critical remarks about the school and staff in the presence of any student or adult at any time. See the teacher or principal if you have concerns.
- 16. Discuss student problems with the teacher before going to the principal.

### **AWARDS**

The principal and teachers will, at the end of each quarter, encourage students to seek excellence in Christian education by recognizing students on the Honor Roll. The criteria for these awards will be scholarship, citizenship, and service, and will be given out at the end of each nine (9) week academic period.

## **CHAPEL SERVICES**

Each classroom will begin its day with worship. The school will schedule a combined chapel service once a week for spiritual emphasis and the promotion of school spirit.

Students may be asked to visit nursing homes and to participate in supervised distribution of literature and food to the needy.

### CONTACTING STUDENTS AND TEACHERS

Avoid calling students and teachers from classes to answer the telephone except in cases of emergency. Our staff will take a message and deliver it at an appropriate time of the day. Teachers will be happy to speak with you before or after school hours.

## PARENTS/ADULTS APPROACHING STUDENTS

Parents/guardians and other adults are not to approach students about grievances they may have. They are to communicate with the teacher or the principal who will in turn approach the student to resolve the matter causing the grievance.

### **EMERGENCY CLOSING**

We will close school in cases of extreme weather conditions or school emergencies, and make up any lost days later in the year. In such cases of school closing, we will make announcements through public media outlets, telephone, and/or text messages. As a general rule, when the Hillsborough County schools close because of bad weather, we will also close.

## FIELD TRIPS

To participate in class and school trips, students must obtain written permission from their parents/guardians.

## FIRE DRILLS

The academy holds regular fire drills during the school year. Students must obey pertinent rules of safety.

### **FIRST AID**

The school will apply first aid to students in cases of minor injuries. We will refer cases of major accidents and illnesses to the most appropriate medical facility, and contact the parents/guardians immediately.

### **IMMUNIZATION**

Students entering Mount Calvary Junior Academy should have a completed and up-to-date immunization form at time of registration. Parents/guardians have thirty (30) days after students enter school to meet this state requirement. Students could be suspended from classes until this state requirement is met.

### STUDENT ILLNESS

A student who is ill should remain at home for the good of the student and the good of his or her classmates and teacher(s). When a student becomes ill at school or shows signs relating to any illness, the parent or an individual listed on the emergency contact form is required to immediately come to the school to pick up the student within 30 minutes of the notification. Until that child has been picked up, the school will provide an isolated place for the child to rest.

## **MEDICATION AUTHORIZATION**

All medication brought to school by and for students must be handed over to the teacher or secretary. The teacher or secretary will allow the student to take the medicine **only** when:

- 1. The medication is in its original container.
- 2. There is verifiable evidence that the medication was prescribed to the student by a healthcare provider.
- 3. The parents/guardians provide written consent.

Medication will be given only when  $\underline{all}$  the conditions above have been met.

Note: Staff members will not administer medication.

#### STUDENT INSURANCE

The school carries liability insurance that covers the students while at school and during all school-sponsored activities. The school's insurance is a secondary insurance and will apply only when a parent does not have insurance.

### **LUNCHES**

We encourage students to bring wholesome lunches and snacks to school. Lunches should include some fresh fruit, fruit juice, vegetable, and whole grain.

We strongly discourage students from bringing meat to school. If you must give your child meat at school, please be sure that it is clean meat.

The use of pork and pork products, lobster, crab, shrimp, Coke, Pepsi, caffeinated, or alcoholic drinks in any form is forbidden. Students are not to bring these products to school or on any school-sponsored trip. Candy and gum should not be brought to school.

A microwave will be provided for students to warm their food. As far as possible, send food that is prepared and ready to be eaten.

# CONCERNS AND COMPLAINTS BY PARENTS OR GUARDIANS

Parents/guardians with concerns should first discuss them with the teacher involved. If your concern is not resolved in a satisfactory manner, you should then see the principal.

If the matter is still not satisfactorily resolved, and you need further discussion or action, the next step is to send a letter to the principal requesting that the matter be heard by the school board.

# PARENT/GUARDIAN-TEACHER-STUDENT CONFERENCES

We schedule these conferences at the end of the first (1<sup>st</sup>) and third (3<sup>rd</sup>) quarters, or when parents/guardians or teachers see a need. Every parent/guardian or student has an opportunity to discuss the instructional program with teachers and plan for continuous home and school cooperation to maintain positive student progress.

# SUPPLIES AND PERSONAL ITEMS

Students are responsible for their own schoolwork and homework. Furthermore, students are expected to keep up with their school supplies.

We encourage parents and guardians to label their children's items such as books, book bags, lunch boxes, coats, hats, clothing, etc., so that we may return lost items to the proper owner.

# **TELEPHONE PRIVILEGES**

Students are not allowed to bring cell phones to school. If a student needs to make an emergency call to a parent/guardian during school hours, he/she may see the secretary or speak to the teacher.

If you think you have a special situation that warrants consideration, speak directly with the principal.

#### SCHOOL COMMUNICATIONS

We will send communications to parents or guardians via the students. Please encourage the students to bring them home for your information and prompt attention. We will also communicate via email, text, our blogs and web site:

#### **CLASSROOM VISITATIONS**

Parents and guardians are always welcome to visit classes and observe our school program. In order to minimize disruptions, we have developed and adopted the following:

**Visitor** refers to anyone other than a registered student of Mount Calvary Junior Academy or a member of the staff.

- 1. All visitors must report to the office upon entering the campus. Under no circumstances should a visitor go to the classroom uninvited. The secretary will contact the teacher and the teacher will decide upon the appropriate course of action.
- 2. Where practical, visits should be by prior arrangement with the teacher. Visitors should inform the teacher of the general purpose of the visit at least twenty-four (24) hours in advance.
- 3. Teachers shall have the right to reschedule a visit.
- 4. When possible, the teacher and visitor should arrange a conference outside of school hours to discuss the visit.

- 5. Visitors should refrain from taking the teacher's attention away from classroom activities for discussions or conferences during a visit.
- 6. A reasonable amount of time for class room visit is approximately fifteen (15) to thirty (30) minutes.
- 7. Preschool children and other non-school children may not visit classes without the permission of the principal.
- 8. Every effort must be made to minimize disruptions during visits.
- 9. Students visiting for more than a day must get permission from the principal and school board.
- 10. A classroom visit is intended for parents/guardians to see how their children function in the classroom setting and to help them to determine how to best help their children to succeed. It is not for the parent/guardian to observe the teacher.

# **EARLY DISMISSAL**

Normally, students are not dismissed during school hours except in cases of illness or for medical appointments.

If at any time it is necessary for a parent/guardian to take their child from school during school hours, please go to the office, sign the early dismissal form, and wait for the secretary to contact the teacher and get the respective student for you.

Students, parent/guardians must comply with all regulations in the school handbook. They will be expected to act in accordance with all written and publicly announced regulations made subsequently.

#### DISCIPLINARY PROCEDURES

For most regular disciplinary issues that do not require immediate suspension or expulsion, the procedures will usually be a follows:

First, a student will be encouraged by the teacher and/or principal to adhere to the rules.

The second step will be a conference with the parent/guardian. If the student persists with misbehavior, suspension will follow.

The final step, if there is no improvement, will be expulsion.

**Suspension** is the temporary removal of the student from school.

**Expulsion** is the removal of the right and obligation of a student to attend school for the remainder of the school year. The school board shall be the only body with the authority to order an expulsion.

Corporal punishment is not permitted at the school. This policy applies to all workers and volunteers of Mount Calvary Junior Academy.

Additionally, parents/guardians are not to ask the principal, teachers or other staff members of this school to administer such punishment to their children on their behalf.
